ALL ITEMS QUOTED ARE SUBJECT TO THE FOLLOWING TERMS AND CONDITIONS. NONE OTHER APPLY UNLESS SPECIFICALLY ACCEPTED IN WRITING BY OUR FIRM.

MINIMUM PURCHASE ORDER IS \$3,500.00 USD

ANY ORDER ISSUED FOR STOCK MATERIAL MUST CITE A DELIVERY OF 7 DAYS. THE 7 DAY PERIOD BEGINS AFTER THE CUSTOMER HAS SIGNED AND RETURNED THE REQUIRED DOCUMENTATION PERTAINING TO THEIR ORDER.

ORDERS RECEIVED THAT DO NOT CITE THE REQUIRED DELIVERY WILL BE REJECTED.

ALL STOCK MATERIAL IS SUBJECT TO PRIOR SALE

WE DO NOT SHIP OUTSIDE OF THE UNITED STATES. ANY SHIPMENTS FOR NON-CONUS DESTINATIONS MUST BE MADE THROUGH FREIGHT FORWARDER.

ALL ORDERS MUST BE FAXED, MAILED, OR SENT ELECTRONICALLY

PLEASE NOTE: YOU WILL BE REQUIRED TO SIGN THE ACCEPTANCE FORM, WHICH IDENTIFIES THAT YOU HAVE RECEIVED AND UNDERSTAND THE TERMS AND CONDITIONS STATED HERIN. UNTIL SUCH TIME, YOUR ORDER WILL NOT BE PROCESSED.

ALL ORDERS ARE TO BE PAID AND SHIPPED AS FOLLOWS

- FEDERAL EXPRESS SERVICES INCLUDE-- PRIORITY 1, 2 DAY, OR EXPRESS SAVER
- PAYMENT IS C.O.D. OR CREDIT CARD. THERE IS A 3% CHARGE ON ALL CREDIT CARD ORDERS WITH THE EXCEPTION OF AMEX. AMEX CARRIES A 4% SURCHARGE.
- ANY ORDER AMOUNTING TO \$2500.00 OR OVER MUST BE PAID BY CERTIFIED FUNDS, WIRE TRANSFER OR CREDIT CARD.
- **3% or 4% processing fee applies**
- ANY ORDER AMOUNTING TO \$7500.00 OR OVER MUST BE PAID IN ADVANCE BY CHECK, WIRE TRANSFER OR CREDIT CARD.

COLLECT ON DELIVERY (COD)

- MUST BE SHIPPED FEDERAL EXPRESS.
- SERVICES INCLUDE-- PRIORITY 1, 2 DAY, OR EXPRESS SAVER ONLY.
- C.O.D.'S CANNOT BE SHIPPED AGAINST YOUR ACCOUNT.

CREDIT CARD

- MASTERCARD, VISA, DISCOVER (THERE IS A 3% PROCESSING FEE ON THESE CREDIT CARDS)
- AMERICAN EXPRESS (THERE IS A 4% PROCESSING FEE ON THIS CREDIT CARD)
- CREDIT CARD ORDERS CAN BE SENT VIA YOUR CHOICE OF TRANSPORTATION. PLEASE SUPPLY YOUR ACCOUNT NO.

INSURANCE

All shipments will automatically be insured for the invoice cost, and the charges will be added to the final shipping cost. Should the Customer elect to waive freight insurance, purchase order must state the insurance waiver AND order must be prepaid in full prior to release of shipment. Customer agrees to be solely responsible for any loss or damage to the shipment if freight insurance is waived. Shipping charges are non-refundable.

Customer will be responsible for refused shipment freight charges and charges will be added to the next invoice total.

PLEASE NOTE THE CONDITION CODE ON THE QUOTATION MUST BE CITED ON YOUR P.O.

THE CONDITION CODE EXPLANATION IS AS FOLLOWS:

NEWLY MANUFACTURED MATERIAL (NE)

New manufactured material is material, which has been manufactured in accordance with applicable drawings and specifications at time of manufacture. Our Certificate of Conformance will be supplied at no additional cost. Full material and processing certifications may be available at additional cost.

NEW SURPLUS MATERIAL (NS)

New surplus material is material, which has been obtained from either a commercial source, U.S. Government source, or FAA 129 source. If applicable, the quotation will identify the trace. Some U.S. Government material will be contained in its original Government packaging. Our Certificate of Conformance will be supplied at no additional cost.

OVERHAULED MATERIAL (OH)

Overhauled material is material, which has been obtained from either a commercial source, U.S. Government source, or FAA 129 source, and either has already been overhauled, or will be overhauled at which time the item is placed on order. Overhauled material will be supplied with either a FAA 8130-3 or JAA Form One. Please note that most FAA 129 trace material does not have a current tag, and the purchaser is responsible for determining if the tag information provided prior to purchase will suit the purchasers need. Our Certificate of Conformance will be supplied at no additional cost.

SERVICEABLE MATERIAL (SVC)

Serviceable material is material, which has been obtained from either a commercial source, U.S. Government source, or FAA 129 source. If applicable, the quotation will identify the trace. Our Certificate of Conformance will be supplied at no additional cost.

AS REMOVED MATERIAL (AR)

As removed material is material, which has been obtained from either a commercial source, U.S. Government source, or FAA 129 source. If applicable, the quotation will identify the trace. No Certificate of Conformance will be furnished with as removed material.

SPECIAL REQUIREMENTS FOR INTERNATIONAL AND EXPORT ORDERS.

If the material quoted is to be delivered to a representative of a foreign country or company, the customer must obtain appropriate license(s) from either the U.S. Department of State or the U.S. Department of Commerce. Purchase orders of international customers **MUST** specify end usage for each item (military or commercial) and the country of ultimate destination.

Unless otherwise noted, this sale, order or quote may include Munitions List Items (MLI) or Commerce Controlled List Items (CCLI). MLI / CCLI property is controlled by the U.S. Government and in many cases cannot be transferred (exported, sold or given) to a foreign country, a non-U.S. Citizen / National or a non – Permanent U.S. Resident without a valid State / Commerce Department export authorization.

It is the responsibility of you (the purchaser) to determine what the applicable requirements may be and to obtain all necessary authorizations, licenses or approvals. “ The use, disposition, export and re-export of the property covered or included in this sale, order or quote is subject to the provisions of law referenced in End-Use Certificate DLA Form 1822, Dec 2001, Including, but not limited to, the Arms Export Control Act (22 USC 2751 et seq.); Export Administration Act of 1979 (50 USC App. 2401 et seq.) as contained under Executive Order 12924; International Traffic in Arms Regulations (22 CFR 120 et seq.); Export Administration Regulations (15 CFR 730 et seq.); Foreign Assets Control Regulations (31 CFT 500 et seq.) and the Espionage Act (18 USC 793 et seq.)”

REQUEST TO RETURN MATERIAL

The condition of material sold against any resultant order, is clearly represented at time of quote. Items sold as serviceable, are NOT guaranteed to be overhauled within any determined economical range. Items sold in as removed condition, are not guaranteed to be complete or functional. We will forward digital pictures of any items prior to shipment if requested. If we ship material that is non-conforming to your accepted purchase order, you are responsible to provide a non-conforming report within three (3) days after receipt of the material. The non-conforming report must provide exactly what is incorrect about the shipment, and what corrective action is requested. Material which is newly manufactured is warranted to be conforming to the applicable drawing(s) or standard(s). We will warrant all manufactured material for a period of twelve (12) months after date of receipt, and either replace the material, or refund the amount paid at our discretion.

RESTOCKING FEE APPLIED TO RETURNED MATERIAL

A restocking fee of 25% is charged for authorized returns.

MANUFACTURED ORDERS

Items produced by our firm are manufactured in accordance with either drawings on hand, or customer supplied drawings. Our firm does not hold any FAA PMA authorization, and therefore items produced **can only be installed on US Government aircraft**. OEM drawings will only be used, if the items being produced are directly for that specific OEM, or for the US Government. If the later, you will be required to supply the US Government contract number prior to us manufacturing the item. Each manufactured order will be accompanied with a manufacturing letter, which stipulates the information cited above. The purchaser will be required to acknowledge this letter prior to engagement of the order. Please refer to the Request to Return Material Clause concerning defective material.
